The following information, for the sake of prudence, clarity and consistency in a document and/ or between different document, regarding pre-bid meeting and four other clarifications in accordance with IB 9/10 is as follows:

2. Following preamble is added before the Price Schedules of Financial Bid.

Preamble to Price Schedules

- i. The Bidders may or may not fill in rates and prices for all (15 nos. Price Schedules) items of the Goods described in the Price Schedules. Items against which no rate or price is entered by a bidder will be considered as the item for which the Bidder is no longer interested to bid. The other Bidders, on the basis of lowest evaluated by the Employer, may be awarded those items.
- ii. The Bidder may not win to supply the items for which his quoted rates are more than the lowest evaluated rates quoted by other Bidders.
- iii. The Bidder shall fill out the prices/rates of his quoted items in the summary sheet, provided at the end of price schedules in Financial Bid.
- iv. Compliance with Statutes, Regulations and Laws:

The Supplier shall, in performing the Framework Contract, comply with applicable Laws. For this purpose, the Supplier shall give all notices, pay all taxes, duties and fees, and obtain all permits, licenses and approvals, as required by the Laws of the Country of origin as well as Pakistan in relation to the transportation, insurance, design, execution and completion of the Services and the remedy of any defects; and the Supplier shall indemnify and hold the Employer/Purchase harmless against and from the consequences of any failure to do so.

- i. Having examined the bidding documents including Instructions to Bidders, Bidding Data, Employer's Requirements with technical specifications and Conditions of Contract, Bid Forms, both technical and financial, Price Schedules and Preamble to Price Schedules and Addenda Nos. _____ for the execution of the above-named work, we, the undersigned, offer to execute and complete the work and remedy any defects therein in conformity with the Conditions of Contract, Employer's Requirements with technical Specifications and characteristics of Goods provided in Price Schedule and Addenda for the rates quoted against each Price Schedule, meeting the requirements mentioned therein or such other rates as may be ascertained in accordance with the preamble to Price Schedules and said conditions. We undertake to accept, out of our offered items, the award of only those items which would have been evaluated as lowest by the Employer and we shall accept the lowest evaluated rates against our quoted rates and our bid price shall be calculated by the Employer accordingly and the same shall be accepted by us (paragraph 1 above, last 4 lines)
- iii. We understand that all the Appendices attached hereto form part of this bid.
- iv. We agree to permit Employer or its representative to inspect our accounts and records and other documents relating to the bid submission and to have them audited by auditors. This permission is extended for verification of any information provided in our Technical Bid.
- v. We undertake, if our bid, priced under above mechanism, is accepted, we will commence and complete the whole of the works assigned to our bid, within the time stipulated in the framework Contract.

- vi. We agree to abide by this bid for the period of 90 days from the date fixed for opening the same and it shall remain binding upon us and may be accepted at any time before the expiration of that period.
- vii. Unless and until a formal Agreement is prepared and executed, this bid, together with your written acceptance thereof, shall constitute a binding contract between us.
- viii. We do hereby declare that the bid is made without any collusion, comparison of figures or arrangement with any other bidder for the works.
- ix. We understand that you are not bound to accept the lowest or any bid you may receive.
- x. We undertake, if our bid is accepted, to execute the Performance Guarantee referred in Conditions of Contract for the due performance of the Contract.
